They were among the very first office buildings to grace Carmel's prestigious Meridian Business Corridor and remain an example of high-class suburban development with their distinguished and impressive appearance.

Combining local expertise from seasoned professionals, superior market research and projections, and the nimble response fostered by its entrepreneurial corporate culture, ZRG delivers exceptional results. Going a step further, ZRG utilizes local, on-site professionals to address its tenants' everyday needs.
